Alexandra graduated *magna cum laude* and Phi Beta Kappa from Harvard College, earned a Master's from the Université de Paris—Sorbonne, and received her Juris Doctor from Yale Law School, where she was executive editor of the *Yale Law Journal* and managing editor of the *Yale Journal of Law & Technology*. After law school, Alexandra served as a law clerk for the Honorable Marsha S. Berzon of the U.S. Court of Appeals for the Ninth Circuit.

In 2019-2020, Alexandra served as the First Amendment Fellow at *The New York Times*, where she litigated freedom of information, libel, and First Amendment cases on behalf of The Times, counseled reporters and editors on copyright and newsgathering issues, and provided prepublication review. Notable achievements include obtaining data on millions of coronavirus cases through a federal FOIA suit against the CDC; defeating a Glomar response by the CIA in a case seeking the Trump Administration's rules governing the use of lethal force abroad; and arguing before the Second Circuit in a successful bid to permit the publication of law enforcement personnel records obtained following the repeal of New York Civil Rights Law 50-a. From 2020-2022, Alexandra served on the Freedom of Information Act Federal Advisory Committee, a position to which she was appointed by the Archivist of the United States. Alexandra currently teaches a seminar on Law & the Arts at Columbia University.
