FAQ

What if I cannot make the interview date work? For schools with early application programs, we will be offering a specific date (*please see page 2*) for screening interviews and we may not be able to accommodate interviews outside of your school's assigned date. We believe that the single-day interview format promotes fairness for all interested students. We ask that you schedule your interview within 48 hours of receiving your invitation.

Will Gibson Dunn also be participating in OCI? We plan to participate in OCI on a very limited basis with the exception of a handful of schools. Please see page 2 for our plans for your law school.

When will callbacks be conducted? We anticipate scheduling callbacks for late June and July.

What is Gibson Dunn's offer deadline? 14 days. This allows us to maximize opportunities for all students interviewing with Gibson Dunn. We will consider offer extensions on a case-by-case basis when needed for individual circumstances and to keep in line with your career office's guidelines.
